



# Executive Order 2324-002

## Order to Continue Funding the Aunt Flow Partnership

Tuesday, October 17, 2023

---

By the authority vested in me as President of the Butler University Student Government Association, and in order to promote the end of menstrual inequity on Butler University's Campus, it is hereby ordered that funds be granted to the Aunt Flow Partnership.

### Section 1: Mission

In the past year, President Emeritus Cade Chezem and myself, then as Chief of Staff, piloted a program in the Atherton Union Restroom in order to fight menstrual inequity in a space that serves people from the greater Indianapolis community as well as students in our Butler community. Additionally, menstrual hygiene products are essential items that too often are unaffordable, unable to be easily accessed, or simply forgotten to be packed in the course of everyday life. None of these facts should prevent someone from getting such a product when one is in need.

### Section 2: Justification (or Rationale based on context)

As this partnership continues to grow, we must continue to support the products and things that we already have on our campus. Due to previous initiative and research conducted, this program serves as the chief agency to ensure the coverage of menstrual inequity on campus. Students have given positive feedback about these products, and do prefer these products to the ones offered elsewhere on campus, thereby promoting a need that should be fulfilled through the student advocacy of the Student Government Association and University Operations. Additionally, these products are completely biodegradable, furthering our commitment to sustainability as an organization. These products, and the machines they are oftentimes stored in, not only provide free product

but are also accessible at an appropriate height to be ADA compliant and utilized by all people.

The quote from Aunt Flow (Appendix A) states that \$1,400 will be necessary to continue to supply product to the Atherton Union project, as well as the other locations currently in discussion of being expanding to, in order to promote the end of menstrual inequity on our campus. This is the same number of supplies that lasted the community nearly 10 months. I hereby allocate this sum from the Executive Projects and Initiatives line item of the Student Government Association budget.


### Section 3: Implementation
